## **COMMERCIAL** MEDIA ENTITLEMENT — Limited number of passes issued

- Annual Photo ID Pass
- Personal Media Identification Bib
- > Filming and photography at all rounds
- Unlimited publication of Video edits throughout the 2022 season (no longer than 2 mins)\*
- Publication of photos
- > Track side access (limited numbers on site at any one time) this is not guaranteed
- Access to RHL Press Officers
- Access to Media Area
- Liquid refreshments
- Media parking
  - \* RHL sign off prior to publication

### **COMMERCIAL** MEDIA INVESTMENT

- Supply of up to 20 accredited Images to RHL per round for sole use of promotion of championship
- Supply of up to 10 video clips to RHL for sole use of promotion of championship upon demand from RHI
- Media Pass Investment Fee £35.00 + VAT per event.

## **LOCAL** MEDIA ENTITLEMENT — Limited number of passes issued

- Event Specific Pass only one granted per season
- > Filming and photography at event for commercial media outlet or news broadcaster
- Publication of 1 x 2 minute film/edit \*
- Access to Media Area
  - \* RHL sign off prior to publication

## **LOCAL** MEDIA INVESTMENT

- ➤ Local coverage announcement of the round of the Championship
- Supply RHL 10 accredited Images to RHL for sole use of promotion of championship
- > Images must be received by RHL no later than 15.00pm on Monday following event

RHL and or the Organiser have the right to refuse application or withdraw pass allocated without redress

#### SUPPORTING DOCUMENTATION

- UTR Unique Tax Reference
- Public Liability minimum of 1 million Off Track (minimum of 5 million Track Access)
- DBS reference/Copy of DBS
- Passport style photograph

#### CONFRIMATION OF APPLICATION

Successful applications will be processed as follows:

- Notification of success application and type of media pass granted.
- Invoice raised in full for all rounds notified as attending Local media exempt
- Photo ID pass will be issued at first event attended
- Media Bib issued at first event attended this is unique to the applicant
- Media Bibs that are lost have a replacement cost of £20.00 plus VAT and cannot be issued at the round notified as they have to be printed with the applicants unique identification





# IMPORTANT INFORMATION

#### **ACCREDITATION AND PASS**

- > Media Accreditation Applications cannot be carried out at the Venue only in advance
- A photo Identification Pass will be issued at the commencement of the season
- > The Photo pass will be programmed for the rounds applied for
- Media Pass only granted to persons 18 years and over.
- Passes are issued at the discretion of the Promotor and mis use of the Media pass will result in the pass being recalled, with no return of financial investment.
- > The granting of the Media pass does not exempt the bearer from local laws and regulations.
- > The designated holder of the Media Pass waives all rights and titles to any legal claim arising from any accident or damage caused in conjunction with their presence at the event.
- The holder of the Media Pass agrees to abide by rules, conditions and limitations imposed by RHL Activities Ltd and Organisers to ensure the proper and safe running of the event.
- > The holder of the Media Pass acknowledge there will be persons competing within the Championship who are protected under the Vulnerable Persons Act 2004 and as such will ensure they are not in breach of this when carrying out filming and photography at the Championship.
- ➤ Local Media Application must be received no later than 10 days prior to event date.

### **MEDIA BIB**

- A Media Bib will be assigned at the beginning of the year with a unique identification code relating to the rounds and pass type allocated.
- > It is the responsibility of the applicant to ensure they bring their Media Bib to all rounds they will be attending.
- No person will be allowed on track without the appropriate Media Bib
- Applicants who request a replacement Bib will incur a charge of £20.00 plus VAT and this will be ordered and given at the next round attended. It cannot be allocated at the event.
- All Media Bibs to be handed in at the end of the last round of the Championship

#### **Track Access**

Access to the track for the Revo ACU British Motocross Championship is limited in numbers in line with event Health and Safety Regulations, for the protection and safety of all concerned.

#### Therefore:

- ➤ Limited number of persons allowed on Track
- ➤ If you require any photos the RHL Media Department will be able to supply a selection after the event following a written request.
- Appropriate footwear must be worn, no flip flops/sandals on Track or trainers/casual footwear. The live track is deemed as a workplace and as such comes under Health & Safety at Work Act, Personal Protective Equipment at Work Regulations 1999

### **Filming Rights**

- Copyright of the event is the sole ownership of RHL Activities Ltd, under licence from the ACU (Auto Cycle Union) and persons applying for media accreditation are acknowledging they will abide with the parameters relating to the relevant pass granted. Any person found to be infringement of this will result in legal action being taken by RHL Activities Ltd.
- Video Edits: Copyright approval for video clip publication in video format (MP4) to media@rhlactivities.com,
- ➤ **Drone Filming:** Authorisation must be received from RHL Activities Ltd, upon production of appropriate insurance, risk assessment and pilot licence, along with aviation authorisation.
- > Social Media Video: tag @acubritishmx & @rhlactivities.
- > Supply of accredited Images to RHL no later than 15.00pm on Monday after event
- Supply of video clips to RHL for use by RHL for promotion of championship within 3 days of request being received
